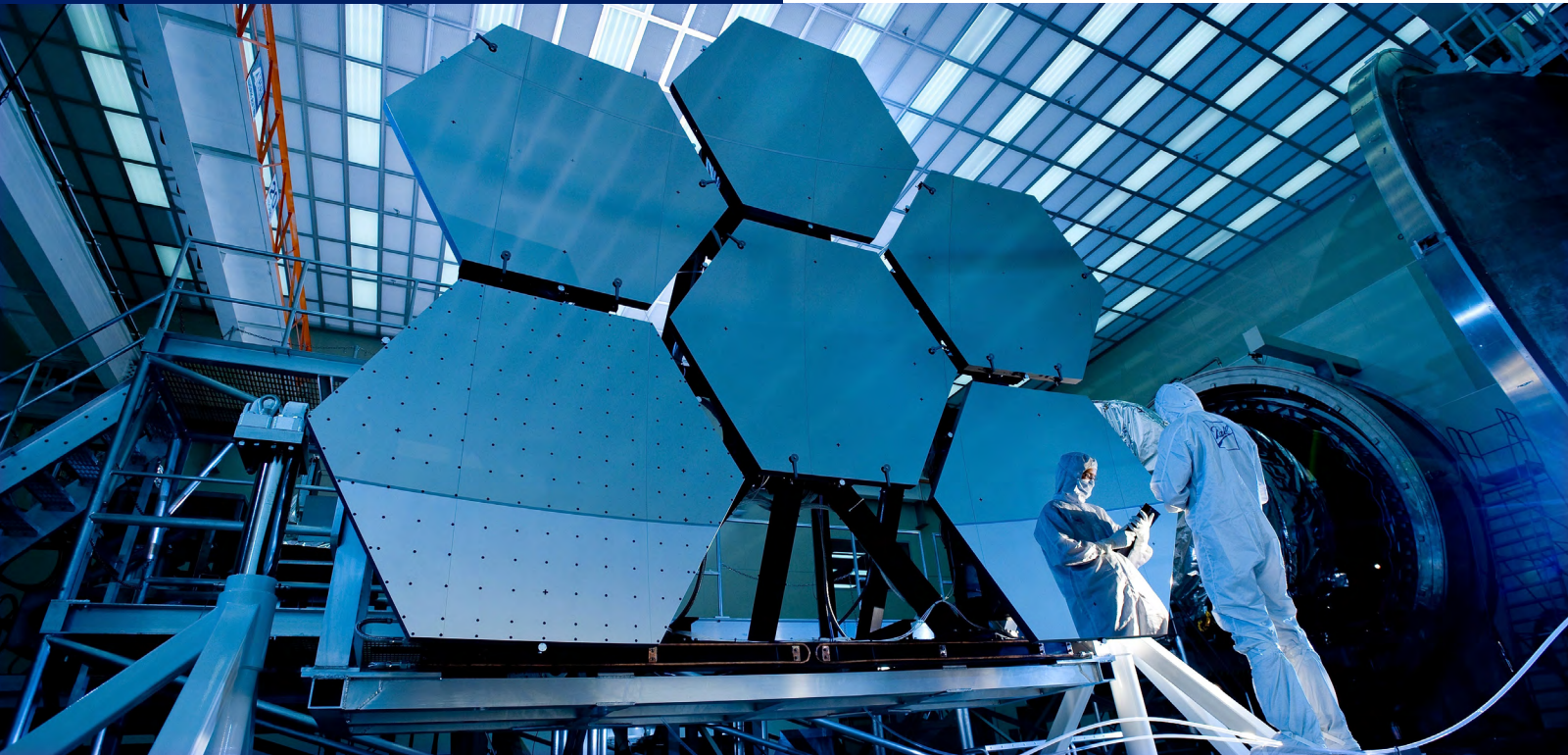

We analyze your sign (name, slogan, logo, numbers, etc.) to **verify its enforceability**. If necessary, **we study the existing**

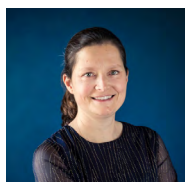
**trademark** portfolio to propose a protection strategy.
